DURING THEIR TIME AT PATHWAYS STUDENTS HAVE OPPORTUNITIES TO: GROW IN THEIR CHRISTIAN FAITH, OPPORTUNITIES TO PARTICIPATE IN CONTINUED EDUCATION, VOLUNTEER IN THE COMMUNITY, AND HAVE AN ACTIVE LIFESTYLE. IN 2017 WE SERVED 53 ADULTS AND THEIR FAMILIES. WE ARE OPEN YEAR-ROUND AND CLOSED FOR A TOTAL OF FOUR WEEKS FOR STAFF TRAINING AND HOLIDAYS.
