PATHWAYS ADULT LEARNING CENTER OPERATES 42.5 HOURS PER WEEK, PROVIDING BOTH FULL-TIME AND PART-TIME ENROLLMENT OPTIONS FOR ADULTS WITH INTELLECTUAL DISABILITIES THROUGH IN-PERSON AND ONLINE CLASSES. THE PROGRAM PROVIDES STUDENTS WITH OPPORTUNITIES TO GROW IN THEIR CHRISTIAN FAITH, AND TO PARTICIPATE IN CONTINUING EDUCATION, LIFE SKILLS TRAINING, VOLUNTEERISM, AND FITNESS ACTIVITIES. IN 2020, THEY SERVED 65 STUDENTS AND THEIR FAMILIES. PATHWAYS PROVIDES SERVICES YEAR-ROUND AND CLOSED FOR A TOTAL OF FOUR WEEKS FOR STAFF TRAINING AND HOLIDAY BREAKS. IN MARCH 2020, WE BEGAN OFFERING VIRTUAL CLASSES AS A TEMPORARY COVID SAFETY MEASURE IN LIEU OF IN-PERSON CLASSES IN ORDER TO PROTECT OUR VULNERABLE STUDENTS. THE CONTENT REMAINED THE SAME. CLASSES REMAINED VIRTUAL THROUGH THE REMAINDER OF 2020 DUE TO THE PANDEMIC RISKS.
